2 *Resolution Authorizing Student Government Association Participation in the Third Annual*
3 *Housing Fair*

5 WHEREAS, the Student Government Association is the official student governing body of
6 Illinois State University;

7

8 WHEREAS, housing is a primary concern of the Student Body;

9

10 WHEREAS, Illinois State University Office of off-Campus and Nontraditional Student Services, a
11 division of the Dean of Students Office and the Daily Vidette are co-sponsoring the Third Annual
12 Housing Fair;

14 WHEREAS, the Student Government Association has been invited to co-sponsor the Housing Fair;

15

16 WHEREAS, the Third Annual Housing Fair educates students on off-campus opportunities;

17

18 WHEREAS, over 700 students participated in the past 2 years of the Housing Fair;

19

20 WHEREAS, previous Student Government Association administrations have failed to meet their
21 requirements concerning the Housing Fair;

23 WHEREAS, the Housing Fair will be held September 30, 2008 from 11:00 AM to 4:00 PM in the
24 Bowling and Billiards Center Activity room, with set-up and tear down occurring one hour before and
25 after the event;

26

27 WHEREAS, members of the Assembly of the Student Government Association are required to be in
28 attendance of the Housing fair for one and a half hours;

29

30 THEREFORE BE IT FURTHER RESOLVED, the Assembly of the Student Government Association
31 authorizes the Student Government Association participation in the Housing Fair and \$1,000 in funding
32 for the Housing Fair to purchase supplies and promotional materials;

33

34 BE IT FURTHER RESOLVED, the Secretary of Governmental Affairs, all On-Campus, and all Off-
35 Campus Senators will be required to staff a Student Government Association table for a period of time as
36 determined by the Secretary of Governmental Affairs;

37

38 BE IT FURTHER RESOLVED, all other members of the Student Government Association will be
39 encouraged to attend and assist in the implementation of the Housing Fair.

41 Adopted by the Assembly of the Student Government Association on the 18 day of July,
42 2008.
