5 WHEREAS, the Student Government Association is the official student governing body for Illinois State
6 University;

8 WHEREAS, it is a goal of the 2011-2012 SGA administration to maintain a consistent physical and
9 online presence in order to collect constituent feedback;

11 WHEREAS, *Educating Illinois 2008-2014: Priorities for Illinois' First Public*
12 University advances the Board of Trustees vision for the University and builds upon the
13 institution's heritage and recent accomplishments;

15 WHEREAS, *Educating Illinois* incorporates the University's mission, vision, and core values
16 (pursuit of learning and scholarship, individualized attention, public opportunity, diversity, and
17 civic engagement) and guides the University in its daily operations and provides a roadmap to
18 the future;

20 WHEREAS, *Educating Illinois 2008-2014* was endorsed by each of the University governance
21 groups in spring 2008;

23 WHEREAS, The University began the process of revising the plan and strategic mission, as
24 charged by the President during his September 2011 State of the University Address;

26 WHEREAS, Student Body President Owens has worked with office of the Vice President of Finance
27 and Planning to host a forum to give students an opportunity to provide input and feedback into the
28 strategic future of the university;

30 WHEREAS, a campus caucus for the campus community will be held February 15th, 2012 at 6 pm in
31 the Old Main room of the Bone Student Center prior to the Assembly meeting;

33 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association authorizes
34 SGA's participation in the Educating Illinois Student Public Forum;

36 THEREFORE, BE IT RESOLVED, attendance to the forum is required for all members of the
37 Association;

39 THEREFORE, BE IT RESOLVED, attendance is strongly encouraged of ex-officio groups and other
40 student leaders;

42 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs Secretary
43 of Public Relations Gill and Vice President of the Assembly McMahon to work with campus media to
44 publicize the event;

46 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs
47 Executive Director Davis to ensure the logistical arrangements are made accordingly.
