6 WHEREAS, the Student Government Association (SGA) is the official student governing body for
7 Illinois State University;

9 WHEREAS, Off-Campus housing is a primary concern of the Student Body and working to better inform
10 students about the leasing process is a goal of the 2010-2011 SGA Administration;

12 WHEREAS, Illinois State University Office of Off-Campus and Nontraditional Student Services, a
13 division of the Dean of Students Office is sponsoring the Fifth Annual Housing Fair;

15 WHEREAS, the Student Government Association has been invited to co-sponsor the Fifth Annual
16 Housing Fair;

18 WHEREAS, the Fifth Annual Housing Fair educates students on off-campus opportunities;

20 WHEREAS, approximately 1,000 students participated in the past 2 years of the Housing Fair;

22 WHEREAS, the Fifth Annual Housing Fair will be held September 29, 2010 from 11:00 AM to 4:00 PM
23 in the Brown Ballroom of the Bone Student Center, with set-up and tear down occurring one hour before
24 and after the event;

26 WHEREAS, SGA members attending will be asking students to participate in the SGA Off-Campus
27 Student Survey;

29 WHEREAS, the Executive Officers, Off-Campus Senators, On-Campus Senators and the Secretary of
30 Government Relations are required to be in attendance of the Housing Fair for one hour;

32 WHEREAS, all other members of the Student Government Association are strongly encouraged to attend;

33

34 WHEREAS, \$800 has been allocated in the FY 11 budget for funding the Housing Fair and purchasing
35 supplies and promotional materials;

37 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association authorizes the
38 participation and co-sponsorship in the Fifth Annual Housing Fair.
