11 WHEREAS, registering students to vote is an important process that will allow more students to  
12 participate in the 2010 elections;

13 WHEREAS, the Civic Engagement Committee has the task of registering students to vote;

14 THEREFORE, BE IT RESOLVED, the Civic Engagement Committee will be on the quad on Thursday,  
15 September 30, 2010 from 9-3pm to register students;

16 BE IT FURTHER RESOLVED, it is required for every member of the Student Government Association  
17 to participate in this event for a minimum of one hour;

18 BE IT FURTHER RESOLVED, this hour can be used toward Canvassing the Campus requirements with  
19 the approval of the Vice President of the Assembly;

20 BE IT FURTHER RESOLVED, the Secretary of Public Relations will be required to advertise this event,  
21 including a press release to the *Daily Vidette*, Facebook event, Student Government Association Twitter  
22 account, and Tumblr;

23 BE IT FURTHER RESOLVED, the Secretary of Public Relations will post pictures of the event on  
24 Flickr;

25 BE IT FURTHER RESOLVED, the Vice President of the Assembly will be required to advertise this  
26 event in at least one constituent email;

27 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association approves  
28 registering students to vote on the quad on September 30, 2010.
