Resolution Authorizing the Co-Sponsorship of Roll out the Red Bowling

**THEREFORE, BE IT RESOLVED**, the Student Government Association authorizes the Co-Sponsorship of Founder's Day 2010;

BE IT FURTHER RESOLVED, the Assembly of the Student Government Association accepts the recommendation of the Finance and Allocation Committee and approves a \$500 allocation for the funding request for the Co-Sponsorship with the Association of Residence Halls;

BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs the Student Body Executive to work with Advisor Olshak to ensure that all appropriate funds are allocated and that all logistical arrangements are made accordingly;

BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs Secretary of Programming Colaric to work with the Secretary of the Assembly Diaz to transmit signatures copies of this resolution to the Association of Residence Halls.
