5 WHEREAS, the Student Government Association is the official student governing body for Illinois State

6 University;

8 WHEREAS, increasing communication between the student body and the University administration is a

9 goal of the 2010-2011 Student Government Association administration;

11 WHEREAS, the Campus Master Plan lays out a long-range plan for the physical development of

12 campus in size, form, character, image and environment;

14 WHEREAS, the Campus Master Plan includes proposed new building growth while at the same time

15 addressing renewal of buildings and defining outdoor spaces that unify all functions of the

16 University;

18 WHEREAS, a student campus master plan public forum was hosted on January 27, 2010, to provide

19 students an extra opportunity to attend that was more conducive with their schedules;

21 WHEREAS, since then the Office of Finance and Planning has made revisions to the master plan and

22 released the first draft;

24 WHEREAS, Vice President of the Assembly Owens has worked with Vice President of Finance and

25 Planning Dan Layzell to host a follow up forum to give students another opportunity to see the

26 updated master plan and provide feedback;

28 WHEREAS, a campus caucus for the campus community will be held October 20th, 2010 at 6 pm in

29 the Circus Room of the Bone Student Center prior to the Assembly meeting;

31 THEREFORE, BE IT RESOLVED, the Assembly of the Student Government Association authorizes

32 SGA's participation in the Campus Master Plan Public Forum;

34 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs Secretary

35 of Public Relations Robles to work with campus media to publicize the event.

37 BE IT FURTHER RESOLVED, the Assembly of the Student Government Association directs

38 Executive Director Martin to ensure the logistical arrangements are made accordingly.
